No. 2890-SEC/1E-85/2015 (Part-I) the 09th September, 2015. — Whereas a Notification under Section 8 of West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994) read with sub section (3) of Section 36 of the West Bengal Municipal Elections Act, 1994 (West Bengal Act XXXIV of 1994), hereinafter referred to as the said Act, has been issued by the State Government *vide* Notification No 621/MA/O/C-4/1E-1/2008 (Pt.-I) dated 09-09-2015 fixing the 03rd October 2015, as the date of poll and 07.00 hrs. to 17.00 hrs. as the hours of poll to elect members to the Municipal Corporations mentioned in the Schedule below;

Now, therefore, in exercise of the power conferred by Section 37 of the said Act, the Commissioner, West Bengal State Election Commission hereby appoints;

- (a) the 16th September, 2015 as the last date for making nomination;
- (b) the 17th September, 2015 for scrutiny of nominations;
- (c) the 19th September, 2015 as the last date of withdrawal of candidatures;
- (d) the 03rd October, 2015 as the date on which a poll shall, if necessary, be taken from 07.00 hrs. to 17.00 hrs. without interruption; and
- (e) the 16th October, 2015 as the date before which the election shall be completed;

No. 2891-SEC/1E-85/2015(Part-I).— the 09th September, 2015.—Whereas a Notification under Section 8 of West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994) read with sub section (3) of Section 36 of the West Bengal Municipal Elections Act, 1994 (West Bengal Act XXXIV of 1994), hereinafter referred to as the said Act, has been issued by the State Government vide No. 622/MA/O/C-4/1E-1/2008(Pt.-I) dated 09-09-2015 fixing the 3rd October 2015, as the date of poll and 07.00 hrs to 17.00 hrs as the hours of poll to elect members to the "declared vacancies" to the added areas of 16 Wards (Ward Nos. 51 to 66) of Howrah Municipal Corporation whose term shall be co-terminus with the term of the existing Councillors elected to the Howrah Municipal Corporation;
