Under that straight line there should be three capital letters also in the Roman Script to represent the abbreviated form of the Municipality as authorized by this Commission (the authorized abbreviation for the Haldia Municipality is HLD). For example for the Municipal Returning Officer, Haldia Municipality the MRO's seal will be -
